The institutions and organizations with names recognized as above seek to enhance academic cooperation among them by developing academic collaboration in organizing fest schools, training and other scientific activities.

Within the framework of the regulations applying in each institution, and subject to the availability of resources, the following programs and activities will be encouraged:

- A) "Joint Organizing" of Scientific Activities: SIP+ Fest School Series, seminars, workshops, conferences, academic meetings and other school outreach and popular activities,
- B) "Exchange of Staff and Students": bilateral funding towards supporting of staff and student exchanges or visits for academic tasks,
- C) "Research": joint research activities, research consulting and visiting of experts for research collaboration and/or for assisting in research group setting up.

The specific areas and details of cooperation within the framework of this agreement shall be discussed and agreed upon in writing by the appropriate authority of each institution, prior to the initiation of any particular program or activity. These will be constituted in an addendum to this memorandum of understanding.

All stated institutions will use their own funds to support this cooperative agreement, in accordance with their budgetary possibilities. The host institution will provide assistance in accommodation for visitors and undergraduate students and must provide working space, library and other facilities in accordance with local standards. The institutions may apply for support from their respective authorities if necessary. Nothing in this document obligates either party to any financial commitments, and neither party has the right to contractually bind, or to represent the other party.


The institutions will submit this agreement for approval by their respective authorities. This memorandum of understanding shall be effective upon signature of the parties and shall remain in force for a period of four years. Thereafter, unless any party specifies their intent to terminate the memorandum in writing six months prior to the termination, the MoU shall be renewed automatically for the same period. Termination of this general memorandum

may be effected upon ...


may be effected upon deliberation of an institution listed. None party has the right to terminate the memorandum without liability giving six months' notice in writing. The memorandum may be amended upon written agreement of all institutions.
